JOB SUMMARY

Plans, organizes, supervises, coordinates, and participates in work activities of assigning crews engaged in the operation, maintenance, and repair of the District's water and wastewater systems, including storage reservoirs, booster stations, chlorinators stations, lift stations, manhole repairs, and pressure regulation valves. Position is subject to extended work hours and emergency call-out.

ESSENTIAL DUTIES AND RESPONSIBILITIES *(including but not limited to)*

- Supervises all field operations employees in construction, maintenance, and replacement of water and wastewater main and service lines.
- Inspects, diagnoses, and repairs failures in water and wastewater mains.
- Supervises operation of equipment such as water pumps, lift stations, Vac-Con, water and wastewater tapping equipment.
- Supervise assigned staff. Involves: Schedule, assign and review work activities. Prioritize and coordinate crew activities. Instruct, guide and check work.
- Responsible for implementation and enforcement of rules and regulations regarding employees and public safety such as using flagmen and erecting barricades.
- Complies with all safety standards as they pertain to equipment, company vehicles and facility operations, including preparing activity and maintenance logs, records, and reports.
- Responds effectively to emergency situations.

REQUIRED SKILLS, EDUCATION & EXPERIENCE

- Associate Degree in Engineering, Construction Technology, Building Trades, or related field; or equivalent combination of education, training, and experience.
- Two (2) years of experience in water and wastewater line construction or maintenance and repair and two (2) years of supervisory experience.
- Texas Class "C" Driver's License and must have acceptable driving record.
- Class "C" Water Distribution Operator License issued by the State of Texas required within two (2) years of appointment.
- Class I Wastewater Collection System License issued by the State of Texas required within two (2) years of appointment.
